



Registration for Authorisation Options

As of the **1st May 2012** Producers, Collection Centers, Dismantlers and Recyclers of Electrical Electronic Equipment, as defined in Schedule 1, shall obtain Authorisation from the appropriate State Pollution Control Board or Pollution Control Committee of Union Territories.

The only exemption to this requirement is micro and small enterprises as defined in the Micro, Small and Medium Enterprises Development Act, 2006 (27 of 2006).

To seek Registration for Authorisation there are two options:

Option 1. Apply direct to each of the appropriate Pollution Control Boards or Pollution Control Committees of the Union Territories where you have explicit responsibilities as defined by the E-Waste (Management and Handling) Rules 2011 using Form 1 which can be obtained from any Pollution Control Board or Pollution Control Committee of Union Territories.

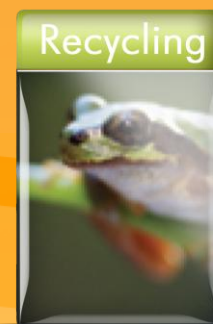
Option 2. Go to www.weeeindia.com and follow the **Three Easy Steps** to Registration for Authorisation:

Step One. Complete the online application form for each of the Authorisations you require with the appropriate agencies and press submit

Step Two. WEEE India will send by e-mail, your unique ID and Password to enable completion of your Online Authorisation paperwork. If you require assistance with this stage of the process just contact info@weeeindia.com and we will arrange one to one assistance by telephone

Step Three. WEEE India will then submit your completed application to the appropriate authorities for Authorisation, alternatively you can print off a copy and send it to the appropriate agencies yourself

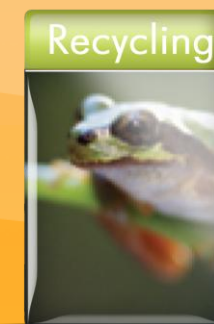

'Extended Producer Responsibility' Producers must set up a compliant take back systems under E Waste (Management and Handling) Rules 2011

Q1 What is 'Extended Producer Responsibility'?

Is the term used to describe Indian Producers explicit responsibility to set up compliant take back system to collect E-Waste (WEEE)

Q2. What does a take back system look like?

1. Responsibilities to set up a complaint take back system are achieved by setting up a collection to recycling systems individually or collectively, which is consistent with the E-Waste (Management and Handling) Rules 2011. The producer is responsible for financing in a transparent manner these individual or collective take back systems.

2. Provide contact details such as address, telephone numbers/helpline number of authorized collection centers for consumers or bulk consumers so as to facilitate your "Extended Producer Responsibilities"

3. Create awareness of your individual or collective take back systems through publications, advertisements, posters, or by any other means of communication and information booklets accompanying the equipment, with regards to:

- a. Hazardous content in the item
- b. Recycling advice including do's and don'ts
- c. Including EN40519 crossed out wheelie bin on the information and/or product to encourage environmentally sound disposal by the consumer
